## **Cookies**

We make use of cookies on this website. A cookie is a simple small file that is sent along with pages from this website (and / or Flash applications) and is stored by your browser on the hard disk of your computer. Cookies are used to store any user names, passwords and personal settings. You do not have to enter your details again during a subsequent visit. Cookies are also used to collect information on the basis of which the visit to and use of the Kerger & Co. B.V. website can be evaluated. A Cookie does not register any personal information or matters that can

The information is transferred to and stored by Google on servers in the United States.
